NOTICE OF PENDENCY AND PROPOSED SETTLEMENT OF CLASS ACTION

IF YOU PURCHASED ALLSCRIPTS HEALTHCARE SOLUTIONS, INC. ("ALLSCRIPTS") PUBLICLY-TRADED SECURITIES BETWEEN MAY 8, 2007 AND FEBRUARY 13, 2008, INCLUSIVE, YOU COULD RECEIVE A PAYMENT FROM A CLASS ACTION SETTLEMENT.

A federal court authorized this Notice. This is not a solicitation from a lawyer.

Securities and Time Period: Allscripts common stock (CUSIP No. 01988P108) and Allscripts options purchased between May 8, 2007 and February 13, 2008, inclusive.

Settlement Fund: \$10,150,000 in cash. Your recovery will depend on the number of shares of Allscripts common stock purchased between May 8, 2007 and February 13, 2008, inclusive, and the timing of your purchases and any sales. If claims are submitted for 100% of the eligible shares of Allscripts common stock, the estimated average recovery per share of common stock will be approximately \$0.288 before deduction of Court-approved fees and expenses. The actual amount per share you could receive will depend on a number of factors that are explained in the Plan of Allocation contained in Question 9 below. The recovery for options cannot be accurately estimated.

Class: The Court has certified a Class of all purchasers of the publicly-traded securities of Allscripts from May 8, 2007 through February 13, 2008, inclusive, and who were damaged thereby. Excluded from the Class are: (i) Defendants; (ii) members of each Individual Defendant's immediate family; (iii) any entity in which Defendants have or had a controlling interest; (iv) officers and directors of Allscripts; and (v) the legal representatives, heirs, successors or assigns of any such excluded party. Also excluded from the Class are those Persons who timely and validly request exclusion from the Class pursuant to this Notice.

Reasons for Settlement: Avoids the costs and risks associated with continued litigation, including the danger of no recovery, and provides a benefit to the Class now.

If the Case Had Not Settled: The Settlement must be compared to the risk of no recovery after contested motions, trial, and likely appeals. A trial is a risky proposition and Plaintiffs might not have prevailed. The claims in this case involve numerous complex legal and factual issues that would require extensive and costly expert testimony. Among the many key issues about which the two sides do not agree are: (1) whether any of the Defendants violated the securities laws or otherwise engaged in any wrongdoing; (2) whether the facts alleged by the Plaintiffs were material, false, misleading or otherwise actionable under the securities laws; (3) whether the various facts alleged by the Plaintiffs influenced the trading prices of Allscripts securities during the relevant period; (4) the method for determining whether the prices of Allscripts securities were artificially inflated during the relevant period; (5) the amount (if any) of such inflation; and (6) the amount of damages (if any) that could be recovered at trial.

Attorneys' Fees and Expenses: Plaintiffs' counsel have not received any payment for their work investigating the facts, conducting this litigation, and negotiating the Settlement on behalf of the Plaintiffs and the Class. Plaintiffs' counsel will ask the Court for attorneys' fees of 25% of the Settlement Fund and expenses not to exceed \$200,000 to be paid from the Settlement Fund. If the above amounts are requested and approved by the Court, the average cost per share of common stock will be approximately \$0.077, making the estimated average recovery per share after fees and expenses \$0.211 if claims are submitted for 100% of the eligible shares of Allscripts common stock.

YOUR LEGAL RIGHTS AND ALTERNATIVES IN THIS SETTLEMENT

SUBMIT A CLAIM	The only way to receive a payment.
OBJECT	You may write to the Court if you do not like this Settlement.
GO TO A HEARING	You may ask to speak in Court about the fairness of the Settlement.
DO NOTHING	Receive no payment.
EXCLUDE YOURSELF	Receive no payment. This is the only option that allows you to bring in another lawsuit against the Defendants relating to the claims being released in this case.

- These rights and alternatives — **and the deadlines to exercise them** — are explained in this Notice.
- The Court in charge of this case must decide whether to approve the Settlement. Payments will be made if the Court approves the Settlement and, if there are any appeals, after appeals are resolved. Please be patient.

BASIC INFORMATION

1. Why Did I Receive This Notice Package?

You or someone in your family may have purchased Allscripts publicly-traded securities between May 8, 2007 and February 13, 2008.

The Court sent you this Notice because you have a right to know about a proposed settlement of a class action lawsuit, and about all of your alternatives, before the Court decides whether to approve the Settlement. If the Court approves the Settlement and after any objections or appeals are resolved, the Claims Administrator appointed by the Court will make the payments that the Settlement allows.

This package explains the lawsuit, the Settlement, your legal rights, what benefits are available, who is eligible for them, and how to get them.

The Court in charge of the case is the United States District Court for the Northern District of Illinois, and the case is known as *Plumbers and Pipefitters Local Union No. 630 Pension-Annuity Trust Fund v. Allscripts-Misys Healthcare Solutions, Inc., et al.*, No. 1:09-cv-04726. The individual and pension fund that sued are called the Plaintiffs, and the company and the individuals they sued, Allscripts, William J. Davis, and Glen E. Tullman, are called the Defendants.

2. What Is This Lawsuit About?

This case was brought as a class action alleging that Defendants made false and misleading statements and omissions on May 8, 2007 about the status of, and delays, development, and installation problems surrounding Allscripts' Electronic Health Record clinical software product, Touch-Works Version 11. Plaintiffs assert that as a result of these false and misleading statements and omissions, the market price of Allscripts common stock was artificially and improperly inflated between May 8, 2007 and February 13, 2008, and that Class Members overpaid for Allscripts common stock and/or options purchased during this time period. Defendants have denied and continue to deny that they did anything wrong or that Members of the Class were damaged.

3. Why Is This a Class Action?

In a class action, one or more people called class representatives (in this case the Court-appointed Lead Plaintiff David Robb and the Court-appointed class representative, City of Aventura Police Officers' Retirement Fund) sue on behalf of people

who have similar claims. Here, all these people are called the Class or Class Members. One court resolves the issues for all Class Members, except for those who timely and validly exclude themselves from the Class. Judge Ruben Castillo is in charge of this class action.

4. Why Is There a Settlement?

The Court did not decide in favor of the Plaintiffs or Defendants. Instead, both sides agreed to a settlement. That way they avoid the cost and uncertainty of a trial, and eligible Class Members who submit valid claims will receive compensation. The Plaintiffs and their attorneys think the Settlement is best for all Class Members.

WHO IS IN THE SETTLEMENT

To see if you will receive money from this Settlement, you first have to determine if you are a Class Member.

5. How Do I Know if I Am Part of the Settlement?

The Class includes ***all purchasers and acquirors of the publicly-traded securities of Allscripts from May 8, 2007 through February 13, 2008, inclusive, and who were damaged thereby.***

6. What Are the Exceptions to Being Included?

You are not a Class Member if you are a Defendant; a member of an Individual Defendant's immediate family; an entity in which any Defendant has or had a controlling interest; an officer or director of Allscripts; or the legal representative, heir, successor or assign of any such excluded party. You are also not a Class Member if you timely and validly request exclusion from the Class pursuant to this Notice.

If you sold Allscripts common stock or options during the Class Period, that alone does not make you a Class Member. You are a Class Member only if you purchased Allscripts common stock or options during the Class Period.

7. I'm Still Not Sure if I Am Included.

If you are still not sure whether you are included, you can ask for free help. You can call Rick Nelson of Robbins Geller Rudman & Dowd LLP at 619/231-1058 for more information. Or you can fill out and return the claim form described in Question 10, to see if you qualify.

THE SETTLEMENT BENEFITS — WHAT YOU GET

8. What Does the Settlement Provide?

Defendants have agreed to cause their D&O Insurer to pay \$10.15 million in cash. The balance of this fund after payment of Court-approved attorneys' fees and expenses and the costs of claims administration, including the costs of printing and mailing this Notice and the cost of publishing newspaper notice (the "Net Settlement Fund") will be divided among all eligible Class Members who send in valid claim forms.

9. How Much Will My Payment Be?

Your share of the Net Settlement Fund will depend on the number of valid claim forms that Class Members send in and the number of shares of Allscripts common stock you purchased during the relevant period and when you bought and sold them. As discussed above in answer to Question 2, Plaintiffs contend that, during the Class Period, Defendants misrepresented and/or failed to disclose certain important facts about Allscripts' Touch-Works Version 11 product. Plaintiffs assert that, as a result, the price of Allscripts common stock was "artificially inflated" during the Class Period and Class Members paid more for Allscripts common stock than they would have if the truth was known. The Plan of Allocation described below is based on this damage theory as well as U.S. Supreme Court decisions that limit recovery for certain purchases and sales during the Class Period.

The allocation is based on the following price declines as well as the statutory PSLRA 90-day look-back amount of \$10.71:

November 9, 2007 Price Decline: \$4.32

February 14, 2008 Price Decline: \$4.12

COMMON STOCK

1. For shares of Allscripts publicly-traded common stock ***purchased or acquired on or between May 8, 2007 through November 8, 2007***, the claim per share shall be as follows:

(a) If sold on or before November 8, 2007, the claim per share is \$0.

(b) If sold on November 9, 2007 through February 13, 2008, the claim per share shall be the lesser of (i) \$4.32 (November 9, 2007 Price Decline), or (ii) the difference between the purchase price and the selling price.

(c) If held at the close of trading on February 13, 2008 and sold on or before May 12, 2008, the claim per share shall be the least of (i) \$8.44 (November 9, 2007 and February 14, 2008 Price Declines), or (ii) the difference between the purchase price and the selling price, or (iii) the difference between the purchase price per share and the average closing price per share up to the date of sale as set forth in the table below.

(d) If held or sold on or after May 13, 2008, the claim per share shall be the lesser of (i) \$8.44 (November 9, 2007 and February 14, 2008 Price Declines), or (ii) the difference between the purchase price per share and \$10.71 per share.

2. For shares of Allscripts publicly-traded common stock ***purchased or acquired on November 9, 2007 through February 13, 2008***, the claim per share shall be as follows:

(a) If sold on or before February 13, 2008, the claim per share is \$0.

(b) If held at the close of trading on February 13, 2008 and sold on or before May 12, 2008, the claim per share shall be the least of (i) \$4.12 (February 14, 2008 Price Decline), or (ii) the difference between the purchase price and the selling price, or (iii) the difference between the purchase price per share and the average closing price per share up to the date of sale as set forth in the table below.

(c) If held or sold on or after May 13, 2008, the claim per share shall be the lesser of (i) \$4.12 (February 14, 2008 Price Decline), or (ii) the difference between the purchase price per share and \$10.71 per share.

CALL OPTIONS

1. For call options on Allscripts common stock ***purchased from May 8, 2007 through February 13, 2008***, and

(a) ***held*** at the close of trading on November 8, 2007 and/or February 13, 2008, the claim per call option is the difference between the price paid for the call option less the proceeds received upon the settlement of the call option contract;

(b) ***not held*** at the close of trading on November 8, 2007 and/or February 13, 2008, the claim per call option is \$0.

2. For call options on Allscripts common stock ***written from May 8, 2007 through February 13, 2008***, the claim per call option is \$0.

PUT OPTIONS

1. For put options on Allscripts common stock **written from May 8, 2007 through February 13, 2008**, and

(a) **held** at the close of trading on November 8, 2007 and/or February 13, 2008, the claim per put option is the difference between the price paid upon settlement of the put option contract less the initial proceeds received upon the sale of the put option contract;

(b) **not held** at the close of trading on November 8, 2007 and/or February 13, 2008, the claim per put option is \$0.

2. For put options on Allscripts common stock **purchased from May 8, 2007 through February 13, 2008**, the claim per put option is \$0.

Note: In the case the option was exercised for Allscripts common stock, the amount paid, or proceeds received, upon the settlement of the option contract equals the intrinsic value of the option using Allscripts common stock's closing price on the date the option was exercised.

Note: The combined recovery for the put/call options shall not exceed 3% of the Net Settlement Fund.

The date of purchase or sale is the "contract" or "trade" date as distinguished from the "settlement" date.

For Class Members who made multiple purchases or sales during the Class Period, the first-in, first-out ("FIFO") method will be applied to such holdings, purchases, and sales for purposes of calculating a claim. Under the FIFO method, sales of common stock during the Class Period will be matched, in chronological order, against common stock purchased during the Class Period.

A Class Member will be eligible to receive a distribution from the Net Settlement Fund only if a Class Member had a net loss. All gains and losses (as calculated under the above plan) will be combined and thereafter netted against each other. In addition, no distribution will be made unless the amount of the check is at least \$10.00.

HOW YOU OBTAIN A PAYMENT — SUBMITTING A CLAIM FORM

10. How Will I Obtain a Payment?

To qualify for payment, you must be an eligible Class Member, send in a timely and valid claim form, and properly document your claim as requested in the claim form. A claim form is enclosed with this Notice. Read the instructions carefully, fill out the form, include all the documents the form asks for, sign it, and mail it in the enclosed envelope postmarked no later than July 18, 2012.

11. When Will I Receive My Payment?

The Court will hold a hearing on July 12, 2012, at 9:45 a.m., to decide whether to approve the Settlement. If Judge Castillo approves the Settlement, there may be appeals. It is always uncertain whether these appeals can be resolved, and resolving them can take time, perhaps several years. Everyone who sends in a claim form will be informed of the determination with respect to their claim. Please be patient.

12. What Am I Giving Up to Receive a Payment or Stay in the Class?

Unless you timely and validly exclude yourself, you are a Member of the Class, and that means that you cannot sue, continue to sue, or be part of any other lawsuit against the Defendants about the Released Claims in this case. It also means that all of the Court's orders will apply to you and legally bind you and you will release your claims in this case against the Defendants. The terms of the release are included in the claim form that is enclosed.

EXCLUDING YOURSELF FROM THE SETTLEMENT

If you do not want a payment from this Settlement, but you want to keep the right to sue or continue to sue the Defendants on your own for the Released Claims in this case, then you must take steps to get out of the Class. This is called excluding yourself or is sometimes referred to as opting out of the Class.

13. How Do I Get Out of the Class?

To exclude yourself from the Class you must send a letter by mail stating that you want to be excluded from *Plumbers and Pipefitters Local Union No. 630 Pension-Annuity Trust Fund v. Allscripts-Misys Healthcare Solutions, Inc., et al.*, No. 1:09-cv-04726. You must include your name, address, telephone number, your signature, and the number of shares of Allscripts common stock and/or options you purchased between May 8, 2007 and February 13, 2008 and the dates of your purchases and any sales. You must mail your exclusion request postmarked no later than June 28, 2012, to:

You cannot exclude yourself on the phone or by e-mail. If you ask to be excluded, you are not eligible to receive any settlement payment, and you cannot object to the Settlement. You will not be legally bound by anything that happens in this lawsuit.

14. If I Do Not Exclude Myself, Can I Sue the Defendants for the Same Thing Later?

No. Unless you timely and validly exclude yourself, you give up any right to sue the Defendants for the Released Claims in this Settlement. If you have a pending lawsuit against any of the Defendants, speak to your lawyer in that case immediately. Remember, the exclusion deadline is June 28, 2012.

15. If I Exclude Myself, Can I Receive Money from This Settlement?

No. If you exclude yourself, do not send in a claim form. But, you may be able to sue, continue to sue, or be part of a different lawsuit involving the Released Claims against the Defendants.

THE LAWYERS REPRESENTING YOU

16. Do I Have a Lawyer in This Case?

The Court appointed the law firm of Robbins Geller Rudman & Dowd LLP to represent you and other Class Members. These lawyers are called Lead Counsel. You will not be directly charged for these lawyers. If you want to be represented by your own lawyer, you may hire one at your own expense.

17. How Will the Lawyers Be Paid?

Lead Counsel will ask the Court for attorneys' fees of 25% of the Settlement Fund and for expenses up to \$200,000, plus interest that is incurred. This amount includes up to \$5,000 for expenses that Plaintiffs incurred representing the Class. Such sums as may be approved by the Court will be paid from the Settlement Fund. Class Members are not personally liable for any such fees or expenses.

The attorneys' fees and expenses requested will be the only payment to Lead Counsel for their efforts in achieving this Settlement and for their risk in undertaking this representation on a wholly contingent basis. Lead Counsel have committed significant time and expenses in litigating this case for the benefit of the Class. To date, Lead Counsel have not been paid for their services in conducting this litigation on behalf of the Plaintiffs and the Class, nor for their substantial expenses. The fees requested will compensate Lead Counsel for their work in achieving the Settlement Fund. The Court will decide what is a reasonable fee award and may award less than the amount requested by Lead Counsel.

OBJECTING TO THE SETTLEMENT

You can tell the Court that you do not agree with the Settlement or some part of it.

18. How Do I Tell the Court that I Do Not Like the Settlement?

If you are a Class Member, you can object to the Settlement if you do not like any part of it, including the Plan of Allocation and the request for attorneys' fees or expenses. You can state the reasons why you think the Court should not approve it. The Court will consider your views. To object, you must send a letter saying that you object to the Settlement in *Plumbers and Pipefitters Local Union No. 630 Pension-Annuity Trust Fund v. Allscripts-Misys Healthcare Solutions, Inc., et al.*, No. 1:09-cv-04726. Be sure to include your name, address, telephone number, your signature, the number of shares of Allscripts common stock and/or options purchased and sold between May 8, 2007 and February 13, 2008, inclusive, the dates of purchases and any sales, and the reasons you object. Any objection must be mailed or delivered such that it is received by **each** of the following no later than June 28, 2012:

19. What's the Difference Between Objecting and Excluding?

Objecting is simply telling the Court that you do not like something about the Settlement. You can object **only if** you stay in the Class. Excluding yourself is telling the Court that you do not want to be part of the Class. If you exclude yourself, you have no basis to object because the case no longer affects you.

THE COURT'S FAIRNESS HEARING

The Court will hold a hearing to decide whether to approve the Settlement. You may attend and you may ask to speak, but you do not have to.

20. When and Where Will the Court Decide Whether to Approve the Settlement?

The Court will hold a fairness hearing at 9:45 a.m., on July 12, 2012, at the Everett McKinley Dirksen United States Courthouse, 219 South Dearborn Street, Chicago, Illinois. At this hearing the Court will consider whether the Settlement is fair, reasonable, and adequate.² The Court may move the date or time of the fairness hearing to a later date and/or time without further written notice to you. If the date or time of the fairness hearing is changed the new date and/or time will be posted at www.gilardi.com. If there are objections, the Court will consider them. Judge Castillo will listen to people who have asked to speak at the hearing. The Court will also consider how much to pay to Plaintiffs' counsel. The Court may decide these issues at the hearing or take them under consideration. We do not know how long these decisions will take.

21. Do I Have to Come to the Hearing?

No. Lead Counsel will answer any questions Judge Castillo may have. But, you are welcome to come at your own expense. If you send an objection, you do not have to come to Court to talk about it. As long as you submitted your written objection on time, the Court will consider it. You may also pay your own lawyer to attend, but it is not necessary.

22. May I Speak at the Hearing?

You may ask the Court for permission to speak at the fairness hearing. To do so, you must send a letter saying that it is your intention to appear in *Plumbers and Pipefitters Local Union No. 630 Pension-Annuity Trust Fund v. Allscripts-Misys Healthcare Solutions, Inc., et al.*, No. 1:09-cv-04726. Be sure to include your name, address, telephone number, your signature, and the number of shares of Allscripts common stock and/or options purchased between May 8, 2007 and February 13, 2008, inclusive. Your notice of intention to appear must be received no later than June 28, 2012, by the Clerk of the Court, Plaintiffs' counsel, and Defendants' counsel, at the three addresses listed in Question 18. If you intend to present evidence or witnesses, you must disclose that information and explain it in your letter. You cannot speak at the hearing if you exclude yourself from the Class.

IF YOU DO NOTHING

23. What Happens if I Do Nothing at All?

If you do nothing, you will be a Class Member. However, you will not receive any money from this Settlement unless you submit a claim form. Unless you exclude yourself, you won't be able to start a lawsuit, continue with a lawsuit, or be part of any other lawsuit against the Defendants about the Released Claims in this case.

GETTING MORE INFORMATION

24. Are There More Details About the Settlement?

This Notice summarizes the proposed Settlement. More details are in the Stipulation of Settlement, dated as of March 16, 2012.
